# UNIVERSITY OF NEW MEXICO STAFF COUNCIL President's Report

## Regents

I'm continuing to work with the Regents through my membership on the ASAR Committee, and my attendance at full Board Meetings and other Committee Meetings. I'm continuing to regularly meet and talk with individual regents to highlight staff and our contributions and to highlight the role of SC.

# President – Dr. Garnett Stokes

The President and I meet monthly. She and I recently discussed the 1% unfunded compensation question and she shared that we have formally requested it from the legislature. We also discussed the policy office and its return to SVP for Finance and Administration. A search is commencing for a new policy office director.

# Provost and Executive Vice President – Dr. James Holloway

The Provost and I meet monthly. This month's meeting was focused almost entirely on unionization and my hope that appropriate precautions are taken to hold staff harmless from any negotiation through this process. I'm also engaging with a small committee of people to advise on the process for the 2020 strategic plan alongside faculty, students, HSC, Equity and Inclusion, and SVP for Finance & Administration.

# Senior VP – Finance & Administration – Teresa Costantinidis

SVP Costantinidis and I meet monthly. Our meeting last month was cancelled due to travel, but our last meeting was productive. She informed me that HR will be doing more to address compensatory changes which effect people at specific salary and benefit thresholds to mitigate increases that mean net decrease in pay. We are also being included in the search for a new policy office director.

# Chancellor HSC – Dr. Paul Roth

Chancellor Roth's office meets with Staff Council on an as-needed basis. We tend to meet quarterly. At our last meeting we discussed some specific questions about HSC

structure, and the policy/staff changes which are ongoing. We also discussed the role of the HSC Staff Committee and its funding moving forward.

### VP Human Resources – Dorothy Anderson

VP Dorothy Anderson and I meet monthly. We are currently engaged in discussion over two recent resolutions which were passed by the SC related to pathways to staff employment for people with disabilities, and tuition remission changes. Each is moving forward, but cannot take further form without action at the policy office.

## Policy Office - TBA

The policy office meets with the Staff Council President, President-elect and Administrator on a monthly basis. This has not been the case since the director of the policy office left UNM in late Spring. Recently, the decision on its reporting structure has been made and SC will be a part of finding a replacement for the office's director.

## Strategic Updates

#### **BLT** update

The Budget Leadership Team meets bi-weekly, and its subcommittees do the same. The budget forecasts have been changing pending our enrollment and we have a projected \$4M shortfall for FY20. This shortfall will be covered using central reserves.

The budget for FY21 is being created and we are assuming a much less rosy outlook than in previous years to avoid mid-year rescissions and other surprises. This means we are starting FY21 in a deficit and BLT is considering the ways to address this for long term stability and to avoid across the board cuts to departments These strategies have ties to the 2020 Strategic Plan and the work of various BLT Subcommittees (like tuition and fee review, and cost-reallocation). I serve on cost-reallocation and we are considering a number of proposals which we may recommend for use in FY21 or for implementation to affect future budgets, including:

- Shared Services
- Fiscal Commons IT Model

- HR Opportunities
- University-wide assessment of programs/deliverables

The Equity in Compensation Task Forces have not been formed, but there is movement at the Department of Higher Ed on our funding model

*Feedback request:* where are the places (of which you're aware) that there are serious compensation inequities? (think Advisors prior to last year's adjustment for all advisors)

## **UNM Seal Committee**

Submissions have now closed and 51 seal designs were submitted. We are reviewing them between now and 11/25 when we will meet to select the finalists to be shared with the public and the Board of Regents.

## Faculty Government Relations Committee

I have been asked, and I recruited Scott, to sit on the Government Relations Committee for Faculty. This is a great opportunity for us to work together to present a united front at the legislature and to help them see *how UNM Staff and Faculty can help them achieve their goals for New Mexico.* I also plan to pursue the possibility that staff put forward a capital outlay request that gets support from UNM Governmental Relations. This will be a future goal, not a 2020 session goal.

# Budget

- Funding Formula
  - Since the funding formula's implementation eight years ago, UNM has exceeded the benchmarks established in the performance-based formula and strongly supports maintaining its current metrics. Institutions should be rewarded for efforts in improving outcomes for students. UNM supports the coordinated request for 8% new money in the funding formula made by the Council of University Presidents, Independent Community Colleges and the Association of Community Colleges.
- School of Medicine I&G
  - The UNM School of Medicine is not part of the funding formula. We seek a percentage parity with the funding received by other institutions throughout the state.
- Compensation Formula Reform
  - UNM supports the state's three higher education associations initiative to revise compensation calculation to include faculty and staff paid with tuition and fees.

# • Compensation

• UNM supports the state's three higher education associations request for 5% compensation based on new compensation calculation. This request will reflect the hard work and dedication of our faculty and staff.

# • NM Health Equity Scholarships

• \$6,000,000 to provide free Medical School tuition for students willing to commit to practicing in NM for four years post-residency.
