#### **UNM Ethics Task Force – Update from January meeting**

All subcommittees are putting together documents that cover the following topics:

- 1. Literature/Resource Review/Research/Best Practice from Peers or others
- 2. UNM existing policy(s) or practice(s) reviewed
- 3. Identification of key/critical issues within the topic
- 4. Recommendations Suggestions for improvement or change, including training improvements/suggestions (Be as specific, as possible)
- 5. Enforcement/Accountability

#### **Subcommittees:**

**Campus Culture** – sexual harassment, social media bullying, lack of knowledge of policies; mandatory training needs to be refreshed and focus on ethical integrity; widespread distrust between groups on campus.

**Financial and Resource Misuse** – reviewing policies and procedures to change. Using peer institutions. Considering mandatory training and code of conduct for financial transactions.

**Consensual Relationship** – considering Limited Prohibition approach with exceptions.

Research Ethics & Academic Ethics (Integrity) – Reviewing policies that UNM uses from Higher Learning Commission and that peer institutions use. Ie. Guidelines on Predatory publishing, whistleblowing, plagiarism and others. Considering trainings

**Conflicts of Interest** – reviewed peer institutions. Best practices include high level COI policies that are applicable to all constituencies.

# UNIVERSITY OF NEW MEXICO STAFF COUNCIL President's Report

#### Regents

A regents meeting will be held on February 18, 2020, ahead of the February Staff Council business meeting, where I will be in attendance. I'm continuing to regularly meet and talk with individual regents to highlight staff and our contributions and to highlight the role of SC.

#### President - Dr. Garnett Stokes

The President and I meet monthly. She and I recently discussed the Gateway Center and its proposed location on campus. We also discussed the search for the EVP for Health Sciences hire, safety measures for the campus, and the possibility of a 5-year salary plan for staff and faculty.

#### Provost and Executive Vice President – Dr. James Holloway

The Provost and I meet monthly. My next meeting will be held next week and we will be discussing the UNM strategic planning process, and updates on the unionization front.

#### Senior VP - Finance & Administration - Teresa Costantinidis

SVP Costantinidis and I meet monthly. Our next meeting will be concerning salary tier recommendations for the health insurance plans and staff compensation guidelines around the margins. We'll also be discussing the Policy Officer hire.

#### Chancellor HSC - Dr. Paul Roth

Chancellor Roth's office meets with Staff Council on an as-needed basis, typically quarterly. You will have heard that this position has been separated into two positions and I'm working hard to ensure that Staff Council has a representative on the hiring committee for this position – which has proved more challenging than originally thought.

#### **VP Human Resources – Dorothy Anderson**

VP Dorothy Anderson and I meet monthly. We are still discussing Resolution 3 from last year, related to staff with disabilities, and a program was approved to create an intern position funded by HSC and SVP for F&A! We are reviewing data surrounding paid parental leave and continuing discussions around equity in compensation per some of your feedback.

## Policy Office - TBA

The Policy Officer position is in the midst of hiring! We interviewed 5 candidates and recommended two candidates to SVP Costantinidis for a second round interview with her personally.

#### **Strategic Updates**

#### **BLT** update

The Budget Leadership Team is faced with making some very sobering recommendations to President Stokes. We have many requests for funding (+\$7M) and without spending a single dollar, are forced to cut \$11M (4%, if across the board) from the budget. Our approach has been to cut beyond what we hope will happen so that we don't have to do mid-year rescissions. We also believe that an across-the-board cut is not an intelligent way to cut. We are recommending that the VPs under President, Provost, and SVP cut their budgets in line with their segment of the general budget.

How each VP/Director/Dean absorbs those cuts will depend on their situation.

We must also spend some money or we risk further consequences in the future. For every \$1 we spend, we must cut \$1. We will recommend the budget to President Stokes this week, and then she to the Board of Regents for their March meeting.

#### **UNM Seal Committee**

The feedback period has now concluded! With over seven thousand submissions, there is a clear favorite, and the rankings and information from the 42-person committee have been provided to President Stokes and

will next go to ASAR (where I have a seat) for recommendation to the full Board of Regents.

#### **Government Relations**

The legislative session is nearly concluded. We will be looking at 1.1% new money from the state, and 3% compensation increase. (The state is not fully funding the compensation increase, but is contributing more than in previous years). In order for the university to truly receive a 3% compensation increase, the university will still contribute about \$1.5M.

#### **FSBC**

After a Town Hall last summer, I asked the Faculty Staff Benefits

Committee (FSBC) to look into the feasibility of adding a fourth tier to our
insurance structure, and to look at the differences in moving the existing
three tiers if this isn't a possibility. Please see the attached report regarding
this request and the subsequent outcome.

## **Gateway Center**

There has been a proposal to use UNM land for Albuquerque's voterapproved Gateway Center. This center, likely housing between 300 and 400 people, would be located South of the Office of the Medical Investigator (OMI) and the UNM Comprehensive Cancer Center.

A series of forums was held to provide information and hear feedback.

I met separately with representatives from the Offices of the President and HSC Chancellor Roth alongside Presidents of ASUNM, and the Faculty Senate, as well as a representative from the Parent Association to get further clarity and address our own questions. There is now a survey circulating so that we may provide feedback. I'd like to hear yours at our business meeting.
