VIII. <u>New Business:</u>

- a. Notice of Bylaw amendments: Councilor Beauchamp spoke about establishing a Permanent Standing Committee, and then gave notice on two bylaw amendment proposals:
 - 1. Article III: Officers; Section 6. Speaker; C: Appoint chairs and members to Staff Council committees **as received from the Committee on Committees**, in consultation with the Executive Committee and with approval of the Staff Council but is not a member of any standing committee.
 - 2. Article V: Committees; Section 1. General; B. As received from the Committee on Committees, and with Staff Council approval, the Speaker appoints the chairs and members of Staff Council committees. Chairs and members will serve a one-year term but may serve successive terms. Committees may choose co-chairs, or two people, to share the work of leading a committee. The Committee on Committees is made up of the Chairs of each Standing Committee, with the Speaker as an ex-officio, non-voting advisor and representative of the Executive Committee.
