Can we help get signs placed and distributed?

We must ask all staff councilors to spread the word to all constituents to bring attention to this and please print and post updated signs locally.

Going deeper to ask Facilities Managers on the status of replacing older lights with LED Bulbs

Single use plastics: Letting staff know that single-use plastics (utensils, clam-shells, beverage cups) should NEVER be added to a recycling bin is of much greater priority from a processing/operational perspective These items make up a very small percentage of the waste stream by weight. Their greater negative impact is that they 'contaminate' the valuable recyclables, increasing the processing cost and commonly causing good material to be landfilled.

Composting success: UNM Food recycled 116 tons of food waste (SUB & La Posada) in 2019. Only 11 tons in 2020. Numbers for 2021 are not yet live.

A success story that is not widely known. There are similar stories (like energy saving programs).

Perhaps our committee should make regular notifications/presentations to the full council regarding these stories.

Educating students: Megan Chibanga (director, RL&SH) has invited John Shaski to include recycling information in the internal RL&SH newsletter.

Rafael Romero-Salas (Student Activities) has asked me to meet privately and brainstorm initiatives that might encourage student participation in recycling.

It's important that our committee notify the council of this activity and...solicit input/action from individual councilors that may have influence amongst these and other student focused groups.

A coordinated effort with a consistent message is bound to improve effectiveness.
